ThinkTank's Support for Life's Little Treasures Foundation and Our Community

When the opportunity came up via my employer to nominate a charity for us to donate to for the last two financial years, nominating LLTF was a no-brainer. Having come through our own experience with two premature babies and knowing many go through a far tougher time than we did, anything we could do to help LLTF provide other parents and families with some extra support was a great feeling."
